From January 1, 2018 through December 31, 2018, the Butler County Detention Facility has a reported rate of less than 0.05% regarding substantiated in custody sexual abuse or sexual harassment for the entire population of over 200 incarcerated individuals.

In 2018, the Butler County Detention Facility continued efforts to maintain compliance with the PREA Detention Standards, and to improve the prevention, detection, and response efforts in regards to in-custody sexual victimization. During 2018, the Butler County Detention Facility had one substantiated allegation of inmate to inmate, sexual harassment and zero substantiated allegations of sexual abuse.

- March 2018 revamped added more detail to PREA Employee Training.
- March 21, 2018 Conducted a PREA Employee Training for all newly hired Detention Staff
- May 8th and 9th, 2018 annual training for all Detention Employees
- PREA Employee Training in the process for Field Training Manual for initial new hires
- Staffing plan reviews
- Updated staffing plan to begin January 1, 2019 in response to several incidents not PREA related
- MOU Victims Advocate Reviewed and signed
- Planning for purchase for future installation of new High Definition NVR's to camera system with more storage capacity. As well as replacement high definition cameras for 6 cameras' that are not working properly.
- On years when refresher PREA Employee training not conducted; PREA Training items disseminated by email and in shift briefings.
